

Privacy Policy

This is the privacy policy ("Privacy Policy") for the Web site ("Site") owned and operated by EducationDynamics, LLC ("EducationDynamics", "We", "Our", "Us"). This Privacy Policy describes how we treat personal information received about you when you visit our Site.

Collection of Your Data

Personal Data. When you fill out a "Student Matching Profile", our Self-Assessment, our Financial Aid Estimator, and at other times, we ask for some information about you, such as your name, age, email address, postal address, and phone number, level of education, desired level of educational program, areas of interest, current occupation, military status (if any), governmental loan status. We do not knowingly collect information from children under the age of 14.

Anonymous Data. As is true of most web sites, we gather certain information automatically and store it in log files. We automatically collect IP addresses and Web site usage information from you when you visit the Site. This information helps us evaluate how our visitors use and navigate the Site on an aggregate basis, including the number and frequency of visitors to each Web page, and the length of their visits. We may combine this automatically collected log information with other information we collect about you. We do this to improve services we offer you, to improve marketing, analytics, or site functionality.

How We Use Your Information and How We Share Your Data

EducationDynamics will not sell or disclose your personally identifiable information except as described below:
